



NEW WATER SERVICE INSTALLATION

Use this form to have a **NEW** water service installed at a property (for example connecting new construction to the water system or switching from well water to city water).

To complete this form, you must:

- Be the Responsible Bill Payee, the Bill Payee's Spouse or Legally Authorized Agent, or the Administrator of the Estate
- Display a Valid Driver's License or state-issued I.D.

OTHER INFORMATION

- A complete water service installation is \$5,500. This is a connection from the water main to the meter setting; there may be additional costs for private plumbing to the city's meter.
- A partial or yard service is \$2,500 (there may also be additional costs for private plumbing to the city's meter). This is the installation from an existing curb valve (on/off valve) to the meter.
- If you think your property only needs a partial service, this can be confirmed by calling 337-8149. Unless this is confirmed, installations will be considered complete water service installations.
- If there is no basement at the property, an outside meter box (ford box) will be installed. If there is a basement, the meter may be installed inside. The certified plumber, who installs the service, will be responsible for the first two years after installation. The City of Kalamazoo will maintain the water line up to and including the meter after the first two years.
- All water installations will be left off until the line has been inspected by the City of Kalamazoo and the meters have been set. Seventy-two-hour notice must be given prior to any work performed by the City of Kalamazoo.

PAYMENT

Payment for all new services can be paid up front or in installments per the following schedule:

- Full Service installs \$5,500 paid over 36 months (\$152.78 per month)
- Partial installs, \$2,500, paid over 24 months (\$104.17 per month)

When the water is turned on, an additional refundable deposit of up to \$60 may be required. Please call our office for details and amounts.
