2. **REPLACE**

Replace the language in SECTION V, SPECIAL CONDITIONS, 5. START-UP AND WARRANTY with the following language:

*The repair contractor shall be on-site to check out the installation and supervise the start-up of the **rebuilt/new** pump. The **rebuilt/new** pump shall be warranted for a period of one (1) year parts and labor after the start-up of the pump. The contractor shall repair or correct at their expense all or any defects to the pump for that time period. This warranty shall include all trouble shooting, travel costs, and cost for removing and reinstalling the pump and motor, if necessary.*

3. **REVISION**

**BID BOND/GUARANTEE** will not be required for this bid. Please disregard all language related to a required bid bond contained within the Invitation for Bids. (**Performance and Payment bonds will still be required for the successful bidder.**)
