  - 2.2. All language contained in the **BID ALTERNATE** specifications, requirements, and conditions of the Invitation for Bids (IFB) and any subsequent addendums referencing removal or installation of the new pump assembly by the Contractor is hereby deleted from the documents. **Removal of the existing pump and installation of the new pump will be the responsibility of the City under the BID ALTERNATE.**
  - 2.3. Performance and Payment bonds will **NOT** be required of the successful bidder for the **BID ALTERNATE**, since the bid alternate is only an equipment purchase.
