This property was presented to the board for a variance for emergency escapes and rescue openings for all bedrooms. The bedrooms have no windows or emergency escapes installed. The apartments are like row houses, no lot line.

Mr. Cherry presented a power point presentation. The presentation included background information on the purchase of 234-238 E Michigan Ave, building permit application process with code information, alternative designs, Building Officials letter to the Harrises, statement of jurisdiction, standard of review, argument and conclusion and request for relief along with exhibits from the Architect.

Mr. Cherry stated that he disagrees with the Building Officials interpretation of the code. Mr. Cherry stated that you must read the language only and stay in the Michigan code.

The application stated that a proposed alternative would be to utilize exception 1 of section 1030.1 and fully equip the building with an automatic sprinkler system.

Mr. Bierlein asked if the buildings common walls are masonry, and it is along with 1 hour fire rated walls & floors.

Mr. Iveson stated his main priority was the safety of the tenants.

Mr. Harris stated that he wants the property to be safe also and he did research on code before purchasing the building.

Mr. Maycroft asked if construction has started yet, and the answer is it has not.

Mr. Brooks stated that you must drill down through the footnotes in the code.

Currently there is 1 exit out of bedroom, 1 exit out of unit to main area and out.

There were no comments from the public.

Chair Van Lente closed the public hearing.

Mr. Maycroft moved that the board grant the appeal application for the variance on requiring emergency escapes and rescue openings in all bedrooms be waived for this property, to accept the Staff Recommendations as stated, seconded by Mr. Beirlein.
