# **Special Presentations:**

- 1. Heather Hemingway presented a volunteer initiative by Eurofins PSS to adopt Henderson Green, focused on STEM education, wellness, and twice-yearly park clean-ups.
- Heather Benac presented on the Academy Green adoption, detailing an ongoing native plant pollinator garden effort. She grew over 1,000 native plants herself and requested modest support for signage and possible reimbursement for minor materials.
- 3. Kalamazoo Junior Girls shared the history and future plans for MLK Jr. Park, including their upcoming 38<sup>th</sup> annual Plant Day on June 8<sup>th</sup>. They discussed long standing involvement in maintaining flower beds, concerns about safety and usability of the park, and the need for infrastructure improvements.

**New Business: Arcadia Park Redesign Update** – Kazmira and Rachel shared an update from the Arcadia Creek Festival Place redesign committee. There was discussion around using a future completed phase of the park for a major fundraising gala to support citywide parks and potentially a future parks millage campaign.
