Parks and Recreation Director Monthly Report: Kazmira Herberger read Patrick McVerry's comments to the board. The park gates and bathrooms closed on October 1st. Staff will begin winterizing bathrooms in anticipation of winter. The SRC field bathroom will stay open through the end of football season for the United/PAL league. Work continues on the Master Plan. A second community input meeting will take place this month at the Farmer's Market. The date will be published this week. The Peace Pole dedication ceremony took place at Crane Park on September 21st. Thank you to Natalie and Chris Patchell for their work on this project and planting the natives around the pole. Planning is in full swing for Halloween Forest and annual Tree Lighting Ceremony. EPA work at Verburg Park will be wrapping up and the boat launch will open on November 28th. Park improvements will go back out for community input in early 2024. Patrick, Ashton, and Chad will be attending the National Parks and Recreation Conference in Dallas, TX next week. This conference is a great opportunity to learn about new trends, suppliers, and best practices in the industry. The City budgeting process is approaching completion. There will be a meeting with Management Services in Mid-October to learn what special requests were approved and the budget for 2024. The initial presentation to City Commission will be in early December with formal adoption at the first meeting in January 2024.
