The purpose of this addendum is to clarify and/or modify the Drawings and/or Specifications for this project. All work affected is subject to all applicable terms and conditions of the Bidding and Contract Documents.

**1. QUESTION 1:** What additional historic research is expected beyond that included as part of the National Register Nomination and online information? Is archival research recommended?

**ANSWER 1:** Archival research should not be necessary. There is a local historic district study report that was drafted in 2022 that contains information about the history of city hall. This can be shared upon request.

- **2. QUESTION 2:** Are there any original or existing drawing or documentation that accurately reflect the current conditions that will be provided to the selected contractor?
  - **ANSWER 2:** Yes there are drawings of the building that can be provided.
- 3. QUESTION 3: Are submitted drawings expected to be scaled?
  - **ANSWER 3:** Yes, drawings should be scaled.
- **4. QUESTION 4:** Will access to both roofs, below grade parking and interior perimeter spaces be available to access? Is fall protection present at upper levels?
  - **ANSWER 4:** Yes, access will be to provided to the spaces mentioned, but we will not be providing fall protection.
- **5. QUESTION 5:** Can any documentations of roofing maintenance or repair records, roofing test cuts (exploratory openings) by others, or facade maintenance or repair records be provided to the selected contractor?

**ANSWER 5:** No, we don't have records of maintenance at this time.
