The purpose of this addendum is to clarify and/or modify the Bid Items, Drawings and/or Specifications for this project. All work affected is subject to all applicable terms and conditions of the Bidding and Contract Documents.

3. MODIFICATIONS TO CONTRACT DOCUMENTS

3.1 SPECIFICATION MODIFICATIONS

- **3.1.1** The specification section title number for natural gas generators is section 16621 (TC-3). Change "Standby Natural Gas Generator Set" Specification section from 16231 to section 16621. Natural Gas Generators page No. 8 For station No. 11 the minimum generator size shall be 500KW. The horsepower of the first load to be started is 150HP. An additional load of 50HP motor blower started across the line is to be included in the load list to be started after the second booster pump and well pumps are started in step No.2 each one at a time.
- **3.1.2** Specification 13410 Section 2.01 A- Add Feyen Zylstra (F&Z) to the list of acceptable equipment suppliers.
- **3.1.3** Specification 16050 Section 3.02- Outdoor conduit (NEMA 4 areas) may be RMC versus PVC Coated RMC.

3.2 DRAWING MODIFICATIONS

- **3.2.1** Sheet No.2 (Remote Site Generators) Add note No. 8 under generators: 8. Existing tank penetrations at Gull Road, and Siesta Tank may be used for the new conduit(s) shown.
- **3.2.2** Sheet No.7 (Remote Site Generators) Add Schneider Electric field engineering services for the ATS work shown at Station No. 4.
- **3.2.3** Sheet I-3 (Sewage Lift Stations Electrical, and Controls Upgrades) the Yagi antennas for Climax, L Avenue, and Augusta-Webster lift stations shall be aimed to the radio pole at Charleston Township.

3.2.4 Sheet E-14 (Sewage Lift Stations Electrical, and Controls Upgrades) - For the work associated with the owner furnished wood pole at L Avenue lift station, this wood pole is being installed at Charleston Township offices and not L Avenue lift station. The work remains unchanged with the exception that the conduits for power and fiber show for L Avenue are to be deleted. Power for the radio panel is by City of Kalamazoo. At L Avenue the Contractor shall furnish and install on the back side of the existing equipment rack a 24-foot 2-inch aluminum schedule 80 mast pipe, 35 feet of ½ inch coaxial cable, lightning arrestor, and Yagi antenna. Yagi antenna furnished by owner, installed by Contractor. Install the ½-inch coaxial cable to the existing panel where the new radio will be located. Radio furnished by owner, installed by Contractor. Mount radio panel on strut rack 24- inches above grade at the Charleston Township office. Attach strut rack and panel to pole. Concrete encase strut rack.
